3. Conditions Governing Match:
  - A. **Rules:**  
 This match was governed by the CMP Competition Rules:  
**Exceptions:** Modified versions of allowed rifles will be permitted
  - B. **Open to:**  
 Any person eligible to compete under the CMP Competition Rules.
  - C. **Course of Fire:**  
 John Garand Match, Course B  
**First Stage** - Slow fire, 200 yards, prone. Maximum of 5 sighting shots and 20 record shots, time limit of 25 minutes.  
**Second Stage** - Rapid fire, 200 yards, prone from standing, 10 record shots with mandatory reload, time limit of 70 seconds.  
**Third Stage** - Rapid fire, 200 yards, sitting from standing, 10 record shots with mandatory reload, time limit of 60 seconds.  
**Fourth Stage** - Slow fire, 200 yards, standing, 10 record shots, time limit of 10 minutes.
  - D. **Rifles Permitted:**  
 Allowed rifles include M1 Garand, M1903 Springfield, M1917 Enfield, M1941 Johnson, M1 Carbine. Rifles may have been modified or accuracy improvements made including improved sights, different calibers, glass-bedding, trigger-job, etc...
  - E. **Ammunition:** Competitors must provide own ammunition.
  - F. **Sanctioned:** This match is **not** sanctioned by the CMP, nor part of the CMP Recreational Target Rifle Event Program.
