A. **Rules:**

This match was governed by the rules prescribed by the CMP Competition Rules.

B. **Open to:**

Any person eligible to compete under the CMP Competition Rules.

C. **Course of Fire:**

John Garand Match, Course B

First Stage - Slow fire, 200 yards, prone. Maximum of 5 sighting shots and 20 record shots, time limit of 25 minutes.

Second Stage - Rapid fire, 200 yards, prone from standing, 10 record shots with mandatory reload, time limit of 80 seconds.

Third Stage - Rapid fire, 200 yards, sitting from standing, 10 record shots with mandatory reload, time limit of 70 seconds.

Fourth Stage - Slow fire, 200 yards, standing, 10 record shots, time limit of 10 minutes.

D. **Rifles Permitted:**

Springfield Match:


As issued U.S. rifle, caliber .30, M1903 Springfield (except low-numbered); caliber .30 M1917 Enfield; U.S. Krag Rifle, that meet CMP Competition Rules and Regulations, 7.2.4.

E. **Ammunition:** Competitors must provide own ammunition.
