**First Stage** - Slow fire, 200 yards, prone. Maximum of 5 sighting shots and 20 record shots, time limit of 25 minutes.

**Second Stage** - Rapid fire, 200 yards, prone from standing, 10 record shots with mandatory reload, time limit of 80 seconds.

**Third Stage** - Rapid fire, 200 yards, sitting from standing, 10 record shots with mandatory reload, time limit of 70 seconds.

**Fourth Stage** - Slow fire, 200 yards, standing, 10 record shots, time limit of 10 minutes.
