3. Conditions Governing Match:
 - A. **Rules:**
 This match will be governed by the rules prescribed by the CMP Competition Rules.
 - B. **Open to:**
 Any person eligible to compete under the CMP Competition Rules.
 - C. **Course of Fire:**
 Course B, 50 shot
First Stage - Slow fire, 200 yards, prone. Maximum of 5 sighting shots and 20 record shots, time limit of 25 minutes.
Second Stage - Rapid fire, 200 yards, prone from standing, 10 record shots with mandatory reload, time limit of 80 seconds.
Third Stage - Rapid fire, 200 yards, sitting from standing, 10 record shots with mandatory reload, time limit of 70 seconds.
Fourth Stage - Slow fire, 200 yards, standing, 10 record shots, time limit of 10 minutes.
 - D. **Rifles Permitted:**
 As issued U.S. rifles as prescribed in the current CMP Competitions Rules and Regulations, for sanctioned CMP Games Matches.
 - E. **Ammunition:** No ammunition will be provided; participants must provide their own ammunition.
