3. Conditions Governing Match:

A. **Rules:**

This match was governed by the rules prescribed by the CMP Competition Rules.

B. **Open to:**

Any person eligible to compete under the CMP Competition Rules.

C. **Course of Fire:**

CMP M1 Carbine Match Course: `

First Stage – Slow fire, 100 yards, prone position. Ten shots, time limit of five minutes.

Second Stage - Rapid fire, 100 yards, prone from standing, 10 record shots with mandatory reload, time limit of 60 seconds.

Third Stage - Rapid fire, 100 yards, sitting (or kneeling) from standing, 10 record shots with mandatory reload, time limit of 60 seconds.

Fourth Stage - Slow fire, 100 yards, standing, 10 record shots, time limit of 10 minutes.

D. **Rifles Permitted:**

Must be a U.S. M1 or M1A1 carbine chambered for the caliber .30 Carbine cartridge complying with CMP rule 6.3.5.

E. **Ammunition:** Competitors must provide own ammunition.
