Eligibility: Open to any individual. There will be team matches if there is demand for them.

CMP Competition Tracker Number: In order to enter scores of competitors in the computer classification system, all competitors who have CMP numbers must provide such number on their entry form.

Rules: Current CMP Pistol Competition Rules will govern for the Georgia Regional. CMP affidavits will be processed during check in.

Awards: Trophies and cash awards will be issued to the Match Winner, Second Overall, Third Overall, as well as the high scorer in each classification. An award for second place in each class will be made, provided there are at least five entries in that class. An award for third place in each class will be made, provided there are at least eight entries in that class. Points and medals for the CMP Service Pistol Match and Distinguished .22 Match are provided by the Civilian Marksmanship Program. All other awards are provided by River Bend Gun Club.

Shooters may enter the Short Course, Service Revolver, Service Pistol and/or .22 EIC matches even if they do not enter the Georgia Regional 2700 match.

A large prize table will be stocked with a wide assortment of valuable gifts provided by local businesses and supporters of River Bend's Bullseye program. Contributions to the prize table from competitors are welcomed.

Classification: The CMP classification system will be used in all matches. Individuals who have not been classified by CMP may use an existing classification, subject to Match Director approval.

Categories: All shooters will compete in an Open Category.

Classes: A minimum of 4 competitors will constitute a class. If less than 4 competitors, those competitors will compete in the next higher class.

Challenges: A challenge fee of \$2 will be charged for each challenge made. See CMP rule 3.10.5 for correct procedure.
