Since becoming the CRO for River Bend Gun Club, I had seen every type of writing, cuneiform and hieroglyphics on the sign-in sheet under the column "Printed Name". Decorum prevents me from inserting photographs of sign-in sheet names that would paint a vivid picture of what I am talking about. Please understand; my intent is not to shame-walk, or embarrass any member in any way. Instead, my intent is to convey the importance of the Club's ability to reach any member based solely on the sign-in sheet information. Here's the story behind the 'why'.

In early April this year, a member – for whatever reason, overlooked a firearm while they were packing to go home. Yes, someone left a firearm on the range and were unaware of its absence. This sort of thing gives me a sinking feeling in the pit of my stomach -I'm certain anyone would feel this way with their mis-placed firearm as well. Abandoned firearms has happened before in River Bend's history. It happened to me personally, and no doubt will happen again at some future date. Luckily, another member discovered the firearm and turned it into the Manager's office. The sign-in sheet entry for the caliber of firearm left on the range that day was not entirely legible. The general manager staff struggled to decipher the name on the sign-in sheet, by querying the database with the name they could clearly identify. After many attempts, they found a name combination they felt they were confident with, to contact a member regarding the firearm found. This story does have a happy ending: owner and firearm were reunited shortly there after.

The CRO wishes to encourage, in the strongest terms possible, that the whole of the membership please print legibly your name when signing in to a range. The story of the lost and reunited firearm is only one of the many instances where Club management needs to find and communicate with members of our community. A clearly printed name enables the Club to be proactive in connecting members with their left-behind items. Imagine the sense of relief getting home to find a message from the Club stating that your firearm (range bag, ammo, wallet, etc.) is secure, waiting for you to come get it.

Please take the few seconds it needs to leave a clear, printed name on the sign-in sheets.

## Message to RBGC Members Regarding the 2022 Annual Business Meeting and Election of Officers

Pursuant to the RBGC, Inc. By-Laws, ARTICLE VIII – MEETINGS, paragraph E. Quorum, "Twenty-five life members of the Club in good standing, in person or by proxy, shall be required for a quorum at any meeting. If a meeting is held in which annual members are entitled to vote, then the presence of twenty-five annual members of the Club in good standing, in person or by proxy, shall be required for a quorum of annual members."

Just prior to the 2022 Annual Business Meeting scheduled to begin at 11:00 AM on 5/15/22, annual and senior members will have the opportunity to elect an Annual Director and life members will have the opportunity to elect two Life Directors and the Club President. In order for the elections to be valid, there must be at least 25 annual / senior members and 25 life members present in person or by proxy.

Although I am certain that annual and senior members will be well represented and a quorum will be easily established, I want to encourage strong participation from the life members because a quorum of life members is required for the successful election of the two Life Directors and the Club President.

As stipulated in the club By-Laws, only Life Members may vote for the President and Life Directors, and only Annual and Senior members may vote for Annual Directors.

Members eligible to vote will be given official ballots at sign-in before the meeting. Members who do not attend the annual meeting may assign a proxy to vote on their behalf by executing a proxy form. **Proxy forms will be emailed to the club membership and will be available for download on the club website after April 15, 2022.**

Properly completed and signed proxy forms must be returned to the Club Secretary no later than 5PM on Friday, May 6, 2022. Proxies received after that date and time will be rejected. Please remember, if you assign your voting rights to a proxy, the club member you assign your proxy to must be present and signed-in at the annual meeting to vote on your behalf, so please be sure that your assigned proxy is going to attend. Also, to be valid, your proxy must be assigned to a specific individual by name. Proxies left blank or assigned to "Board of Directors" or anything other than an individual name will be disallowed. Any member who authorizes another member to act on their behalf at a specific meeting via proxy may not vote at the meeting specified.

River Bend Gun Club is a special place. I love this club and I will do everything possible to help the club continue to grow and remain financially healthy.

### **Additional Statement:**

I am a candidate for club president because I want to help River Bend Gun Club continue to be a gun club that is vibrant, safe, fun and debt free. If re-elected, I will continue to work closely with the Board of Directors, employees and members to help keep our club on the path to success.

I joined RBGC in July 1997 and I have served the club in multiple capacities since 2009. As CRO (2012 to 2018), I participated in monthly Board of Directors meetings and developed good working relationships with the Club President, Board members, club officers, employees and with the ROs and AROs. For six years, I conducted the monthly New Member Orientation (NMO) and I

continue to attend and occasionally teach monthly NMO classes. This allows me to meet new club members, to get to know them and to understand the things they care about. Frequent interaction with club members helps me understand how they feel about club operations, what our challenges are and what resources are available.

As club president in 2018-2019, I guided the club's purchase of an additional 55 acres. This was a challenging and successful effort to expand the club and establish an additional buffer to protect the club from future urban encroachment and the team work and dedication of many club members helped make this possible. Since being elected to three additional terms as club president, I have continued to work closely with the Board of Directors, with club management and with club members to ensure that the club operates within budget, continues to grow and runs smoothly.

In March 2019, we began sending the Bullet-In monthly newsletter to the entire membership via monthly email distribution. The new Bullseye Pistol Range, completed in April 2019, was dedicated as the Ken Smith Bullseye Pistol Range in May. In October 2020, spent bullet removal and impact berm rehabilitation operations were completed on multiple ranges to significantly reduce ricochet hazard and make high-volume ranges safer to use. Approximately 98,000 pounds of spent bullet material was removed and sold to smelting operators in South America to cover all costs for this project. The Action Pistol Complex expansion from three to five bays was completed in December 2020. In May 2021, the new and greatly improved RBGC website launched. This new website allows club members to renew their membership on line via credit card and it significantly improves the efficiency and convenience of the renewal process. In October 2021, the access roads to the Rimfire Rifle Range, Ken Smith Bullseye Pistol Range and Centerfire Rifle Silhouette Range were paved.

I will continue to do my best for the club and its members in any position I hold. The club is blessed with an energetic, well balanced Board of Directors and an enthusiastic membership. As a dedicated and loyal club member, I ask for your continued support by re-electing me as Club President in May 2022. I look forward to working with the Board, club employees and members to build on our successes and to continue to help River Bend Gun Club remain the special place it has become.

I'm running for club president to help maintain and improve RBGC's high standards in addition to encouraging firearms competition and improve facilities that support shooting sports.

I've been a member since 2017 and have supported many of the shooting initiatives such as WOT, Young Shooters Challenge, the River Bend Ballistic Challenge Glock Match, the USPSA State and monthly USPSA matches.

My interest and participation led me to develop a WOT New Shooter Next Steps presentation. The New Shooter Next Steps provides a comprehensive review of the most popular shooting venues and how they should be approached based on skill level. It also includes the equipment needed, cost, how to register and whom to contact.

My participation and interest in stage building, registration and stats provides a well-rounded view of the shooting Venus structure and interest.

As for my background, I have previous experience starting and managing a club from creation as well as holding the office of president. Like RBGC, the club was a non-profit and relied on member volunteers. I grew the club from a few members to several hundred by providing a network of services; a directory of resources; organized vendor training; and acted as a liaison between vendors and members to resolve problems.

I've been in information technology for over 40 years and have recently retired. I started as a developer and moved into other areas such as system architecture, project and program management. I've managed over 50 projects that were large and small with budgets exceeding over \$400 million. I've managed the hiring, firing and annual reviews of employees and contractors.

The projects and programs that I've worked on include planning, oversight, process, implementation and delivery. A few examples of the projects include tabletop disaster recovery exercises for the State of Georgia, where I created disasters and led the recovery. A tabletop exercise is a series of meetings that simulate an emergency situation and the response to a man-made or natural disaster.

I've led the implementation of new internet data centers and the migration of applications. I've managed the replacement of Contact Centers that include banks, large cellular companies and state agencies such as child services. One implementation had 5,000 customer service agents that had to be trained as the new system went live. Another project was to implement controls due to a breach by hackers.

I'm a certified PMP (Professional Project Manager) and have my CBCP certification (Certified Business Continuity Professional). A Certified Business Continuity Professional has knowledge and skill in business continuity/disaster recovery industry.

I'm enthusiastic and passionate about shooting and enjoy reloading.

Lastly, I wish to thank the current president and Board of Directors. These members spend a great deal of their personal time making River Bend a premiere gun club.

# Official Club Business

## Highlights of the March 14, 2022 Board of Directors Meeting

President Will Owensby presided over a quorum of seven Board members. Also attending were four club officers, the Club Manager, the Assistant Club Manager, two life members and one life member spouse. The meeting was convened at 7:00PM on Monday, March 14, 2022. The meeting was held at RBGC's Gene Mowell Conference Center on club property.

A quorum was confirmed, the proposed agenda was adopted, the minutes of the February 14, 2022, Board meeting were approved, and the following officer and manager reports were presented and accepted:

Treasurer Secretary Chief Range Officer Club Manager Shotgun Manager

Board decisions made, actions taken, and items of interest:

- Treasurer Geoff Rhines reported that February FYTD income was \$832K, an increase of approximately \$43K versus the same period in FY 2021.
- February FYTD expense was \$687K, an increase of approximately \$71K versus the same period in FY 2021.
- Cash in the bank as of 2/28/22 was \$274,129 including \$100,213 in Capital Reserve Fund.
- Club Secretary Erica D'Amico reported that the membership total at the beginning of the March 2022 meeting was 2,206, 14 members more than last month.
- The number of Senior Members in March 2022 was 200 (9.06% of RBGC membership).
- Chief Range Officer Jim Garner reported that the Range Use Summary Report for February 2022 totaled 2,100 (1,794 members and 306 guests).
- Eleven venues submitted Match Use Summary Reports for February 2022. Total entries were 312 (154 members, 149 non-members, and 9 juniors). February match income was \$4,415.00 with \$866.78 reported to the club.
- There was a New Member Orientation (NMO) class held on February 27, 2022, for 16 attendees.
- There were 8 Tac Rifle Certifications, 0 NFA Certifications, and 1 Supergun Certification in February.
- Tim Downing was approved by the Board as ARO for Steel Challenge.
- A CPR+ Class will be offered to the membership once a month at no charge.
- Club Manager Bill Illg reported that the maintenance crew has devised straps to hold the baffles on the Ken Smith Bullseye Pistol Range in place.
- New bowling pins were installed on the plate rack on AP1.
- All 20-pound propane tanks have been filled.
- RBGC has a signed agreement from Sweet Water Engineering for ten plate racks (5 with round plates and 5 with bowling pin plates). The price of \$1,750 per rack is locked in for the next two years.
- Shotgun Hill Manager Bill Wettingfeld reported that shotgun range use in February 2022 was 315 shooters (254 members and 61 guests). 965 rounds were fired during February with 15 cart rentals. Total February revenue to the club was \$6,272.
- Member Communications Manager David Norcross reported that the March Bullet-IN reached 2,213 recipients with 2,211 successful deliveries. Open rate was 1,490 (67.4%) and 630 (28.5%) members clicked through the newsletter.
- Facilities Committee Chairman Art Thompson reported that the sketch of the AP5 Berm Conex project has been completed.
- Creation of drawing for 30'w x 40'l pavilion in is process for the AP pavilion project.
- The MP3 project, MP2 reconfiguration as part of Action Shooting Complex, and CB6 Range Floor Test Bay projects are still in preliminary stage.
- The Board approved 12 new members and 0 reinstatements.

Simon and Fran were on hand for the opening match of the 2022 season to help myself and new Stat Officer Jeanette Bias with getting the 'paper work' organized. Again, many thanks to them. Saturday started with temperatures hovering around 34 degrees and the sun trying to come out. The fickle River Bend wind was active with occasional gusts strong enough to make it a bit uncomfortable. Overall, the day was nice with late morning sun warming up to reasonable temperatures.



The match started about 9:45am with a total of 12 competitors comprised of 10 members, 1 guest and 1 youth. The classifications were 6 Marksman, 4 Sharpshooter, 1 Expert and 1 Unclassified Master. Moving some shooters around to create 3 classes, we ended up with 6 Marksman, 3 Sharpshooters and 3 Masters.



The match started off with George Wilson jumping out to a 2 stage total of 186-0X, followed closely by Mat Whitley at 178-0X and Brad Reynolds at 176-0X. On the heels of the top three were the other competitors with scores in the high 160's and mid 170's.

## Rimfire Benchrest Match Report

Sunday, April 25, 2022 greeted 17 eager Rimfire benchrest competitors with mild temperatures, clear blue skies and the promise of light to manageable wind – a seemingly perfect day! Several first time shooters were on hand making up a capacity single relay - plus one – and all four classes were represented. The Semiauto class and Factor classes fired against the RBA 50 target while the Precision and Unlimited classes fired the much more challenging RBA target.

With very still conditions, high scores were expected, and the shooters did not disappoint. In the semiauto class, Paul Lemley and his Brownell's Custom and SK ammo started out with a 249-8X. In the Factory class, the first card resulted in an almost three-way tie for first with Drew McKay and his trusty Lithgow 101 scoring a 248-9X tied with Alan Rauber using his antique BSA International. Bob Morris and his Kimber 92G also posted a 248 but with only 6X's.



In the Precision class, new shooter David Abraham and his extremely tricked out CZ 457 based rig fired a 238-6X to take first Precision, while in the Unlimited class two shooters fired a clean 250 – the first time two shooters fired cleans in a single stage. Grant Toman and his Turbo X-3 with a Broughton barrel and Eley Blue box posted a 250-16X, only to be bested by John McBrayer and his Turbo and his made in Germany Lothar-Walther barrel firing Lapua Midas+ posted a 250-19X to take first place on X count.



The wind started making itself felt on the second card and coming to full impact on the third card along with significant mirage. There were some stable right to left conditions, but mostly the wind just switched around - did what wind does – mess up precise shooting! Scores dropped commensurate with the increasing wind and mirage, but some shooters improved as the match wore on.

In the Semiauto class, after two cards Angelina Lemley had pulled to within three points of husband Paul and after three cards, Angelina was a single point back with a 726-15X to Paul's 727-21X. Among the Factory shooters, Morris was just 4X's behind McKay and after the third card he took over first place with a 741-22X. A strong third card by Rauber and slip by McKay put Rauber at second factory with a 736-26X to McKay's 732-22X.

In Precision class, Abraham continued to dominate through the second and third card to stay ahead with a 685-17X after three. After two cards, the top three Unlimited shooters were separated by just two points. McBrayer held first with a 499-36X, Toman held second with a 498-31X, and Joe Ettershank and his amazing Calfee Turbo gun "Chisum" was in third with a 497-30X. After their third card, Toman's extremely consistent shooting put him into first by two points over McBrayer with a 747-40X.

The final card saw a slight increase in wind, but some conditions wiped away the mirage and were quite shootable – if you were patient.

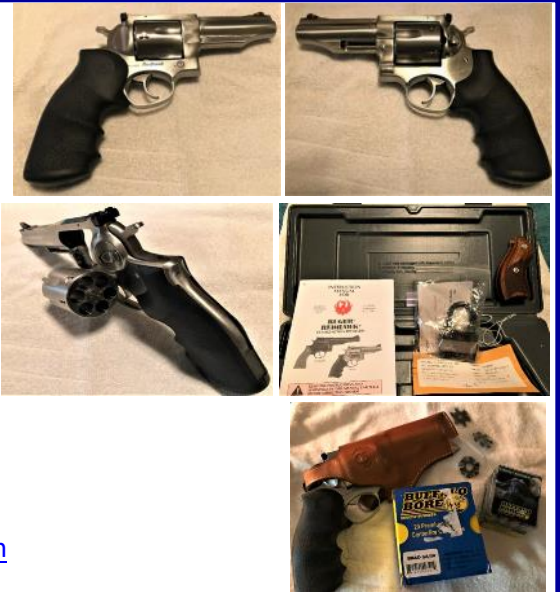

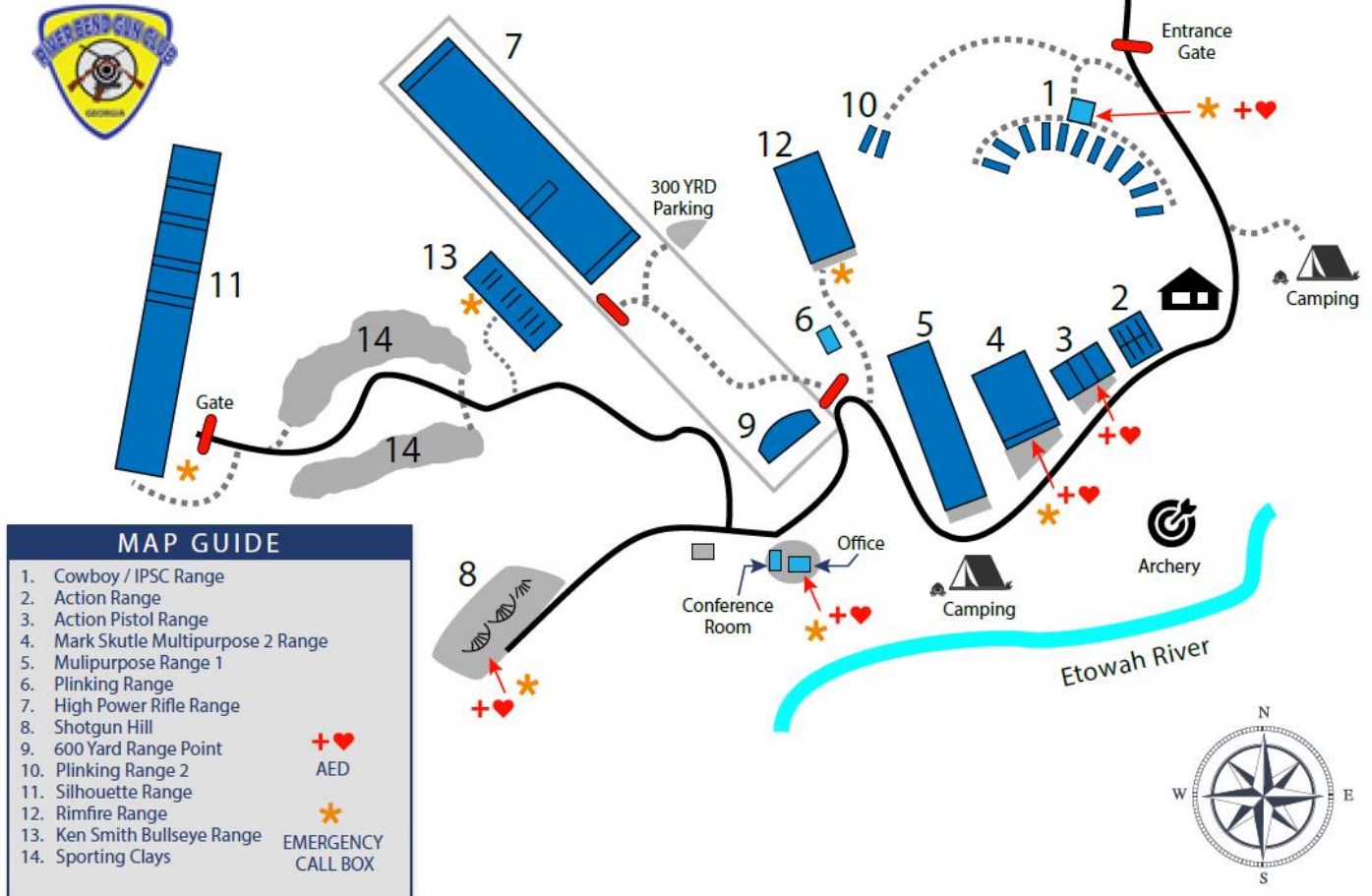
